

Our Emergency Services Fund has been busy! We have given five grants to St. Clair County organizations so far and we are just getting started!



~ TRI-HOSPITAL EMS ~

On April 17, 2020, UWSCC approved a grant for Tri-Hospital EMS through our Emergency Services Fund ~ COVID-19 Relief. Funds have provided for five UV commercial grade disinfectant devices and replacement UV bulbs. This equipment has the potential to both reduce the spread of COVID-19 and prevent cross contamination and will be used in addition to chemical disinfects already used with the emergency response vehicles. The proposal for UV devices from Tri-Hospital EMS was received through a collaboration with Community Foundation of St. Clair County.

It is time to rebuild the community. It is going to take individuals, nonprofits, businesses, and government working together to get it done. UWSCC is at the forefront of building stronger systems and communities that put people first. Grants are still available for St. Clair County organizations and businesses with unexpected costs due to the COVID-19 pandemic.

#### ~ MID CITY NUTRITION PROGRAM ~

On June 2, 2020, UWSCC approved a grant for Mid City Nutrition Program (Mid City) through our Emergency Services Fund ~ COVID-19 Relief. Mid City is one of our Affiliated Organizations. UWSCC appreciates that Mid City is staying connected with their clients to assure that they do not go hungry. Due to the COVID-19 pandemic, Mid City has made necessary adjustments to their program to ensure that their guests are

being served safely; this includes carry-out lunches. UWSCC recognizes the long-term impact this crisis may have on Mid City's organization and the way services are provided. Their organization's commitment to the community and other organizations is admirable. The awarded funds will cover costs for food or meal packaging.

UWSCC has designated funds available to help organizations address unique needs specific to COVID-19 in St. Clair County. Thanks to additional support from other people and organizations, UWSCC is able to continue to address unforeseeable, unique needs in the community that are rooted in the COVID-19 pandemic. These funds are intended to help address emergency needs of organizations while assuring financial support is available to aid in future recovery efforts. UWSCC is focused on maintaining accountability by utilizing the volunteer COVID-19 Emergency Response Committee to review COVID-19 funding proposals that are submitted through an online process.
