Campaign and Allocations - Provide resources to allow for the development, and/or growth of local human service programs and projects to address identified and emerging community needs. To accomplish this resources are solicited County wide in an organized annual giving campaign and then allocated through a grant process to various human service organizations. These grants are monitored throughout the year to assure accountability to the donors and recipients of services. Additionally, the campaign and allocations processes provide a vehicle for donors to establish designated funds to address community needs that they personally consider relevant either during their lifetime or after, from their estate. All campaign, allocations and grant monitoring are done by volunteers with the support of a small staff. Over 50,000 residents are provided needed services annually.

4b (Code:) (Expenses \$ 180,868 including grants of \$ 109,210) (Revenue \$)
Direct Services/Donor Designated Funds - Direct services and donor designated funds exist to assist low income residents with cancer, disabilities, substance abuse, dental and emergency needs. These funds provide assistance to appropriate vendors/provides for: rent, food, utilities, medications, ability appliances, accessibility ramps, or treatment. Additionally, a medical equipment loan closet and supply depot are maintained for donation and redistribution of usable equipment and supplies. Over 1,500 residents are assisted in this manner annually. Accountability and oversight controls are provided by policies determined by the all volunteer Board of Directors and carried out by the staff.
